

Terms and conditions of the Feel Sloveni@ Online Training prize draw at www.Slovenia.info

1. General provisions

The Feel Sloveni@ Online Training prize draw is organised by the Slovenian Tourist Board, Dimičeva 13, Ljubljana (hereinafter: the Organiser) and will be carried out via the www.Slovenia.info website **from 10 November to 23 November 2021**.

This prize draw aims to increase the visibility of Slovenia as a tourist and MICE destination among foreign tour operators, travel agents and MICE clients.

By taking part in the competition, the participants are deemed to have fully accepted and agreed to the Terms and Conditions of the Feel Sloveni@ Online Training prize draw available at www.Slovenia.info.

2. Terms and conditions of participation in the Feel Sloveni@ Online Training prize draw

- a) The prize draw is open to all natural persons, working as a tour operator, travel agent or MICE client with a permanent or temporary residence in the European Union, United States and Canada, Middle East or Asia, over the age of 18, who enter the giveaway via the website www.slovenia.info.
- b) Employees of the Slovenian Tourist Board are not allowed to participate in the prize draw.
- c) Participants of the competition shall cover any costs of participation in the prize quiz. Participation costs may include internet access and internet data transfer costs.
- d) The winning participants expressly grant their permission for their full name to be published on the www.slovenia.info website.

3. Participation in the prize draw and notifying the winners

- a) Individuals can participate by completing the Feel Sloveni@ Online Training available at www.slovenia.info and obtaining the "I feel Slovenia Certified Expert"
- c) The prize cannot be transferred to a third person.
- d) The prize cannot be exchanged or redeemed in the form of its monetary equivalent.

- e) A committee of three representatives of the Slovenian Tourist Board is responsible for the organisation, implementation and supervision of the the draw.
- f) The draw is performed by the committee using e-tools.
- g) The prize competition results are final. They are not subject to appeal. A participant can only win once.
- j) Winners will receive a valuable prize. They will be notified of the draw by e-mail at the provided address. Ten (10) days after the e-mail notification has been sent, the winner must write a reply to the Organiser confirming the receipt of the prize. If they fail to reply to the e-mail in due time, they forfeit their right to the prize and the Organiser draws a new winner. The winner and the Organiser reach an agreement on the manner and the time of accepting the prize by e-mail.

4. Description of the prizes

- Thermo bottle I feel Slovenia (10 pax)

The value of thermo bottle is less than EUR 42.00, therefore no personal income tax will be charged pursuant to the Personal Income Tax Act (ZDoh-2) nor will the value of the prize be included in the prize recipient's tax base.

By participating in the prize quiz, the participants permit the Organiser to collect, process and store the personal data provided in accordance with the applicable European and Slovenian legislation governing personal data protection. 8. Settlement of disputes
