No additional supporting documents are to be delivered at this stage.</p> <p>– In the “Second step”, the pre-selected project proposals will be invited to submit an Application Package including a fully developed Application Form (AF), which will contain more in-depth information about the content and it will be the basis for the selection of the project proposals.</p>
