The common agricultural policy (CAP) is a policy for all the citizens of the EU and the benefits that it provides to them must be clearly demonstrated.</p>

Kratek opis predmeta razpisa:	<p>The overall objective of this action is to strengthen cluster management excellence and facilitate exchanges and strategic partnering between clusters and specialised eco-systems and cities across Europe, including through implementation of the “ClusterXchange” mobility scheme. As high quality cluster management and strategic connections between clusters are key elements of successful world-class clusters, the action aims to foster SME competitiveness and assist companies to successfully access global markets.</p> <p>The specific objective is to enhance the collaboration, networking and learning of cluster organisations and their members towards the professionalization of specialised and customised business support services provided or channelled to SMEs.
