Participation of entrepreneurs from underrepresented countries in the programme will also be encouraged through specific quantitative requirements.</p> <p>This action also aims at offering opportunities to entrepreneurs from SMP participating countries to foster an exchange of business knowledge and expertise in new destinations beyond SMP countries.</p>
