## 6<sup>th</sup> International Contest of Naturalistic Photography DELTA IN FOCUS 2012

---

### REGULATION

#### Art. 1 Promoting subject

The 6<sup>th</sup> international Contest of Naturalistic Photography – Delta in Focus 2012 is promoted and organized by Delta 2000 limited liability Consortium Company with head office in San Giovanni di Ostellato (FE) in Strada Luigia, 8.

#### Art. 2 Subject of works in contest

A photographic prize contest is announced, focused on birdlife, natural landscape and Slow Tourism subjects.

#### Art. 3 Categories

- 1. Birdlife of Po Delta Park**

Images must withdraw birds belonging to the birdlife of Po Delta Park

- 2. Birdlife of the world**

Images can withdraw birds belonging to the birdlife of all the world

- 3. Natural landscape**

Images must withdraw natural and intact environments

- 4. Slow Tourism**

Images can withdraw tourists doing "slow tourism"\*

\*we mean forms of tourism that pay special attention to the concepts of sustainability, responsibility and eco-compatibility. For example: trekking, excursions, horse riding, bicycles and mountain bike, canoeing and other water sports, birdwatching and cultural tourism. #### Art. 4 Typology and requirements of photographic images

- Only digital or digitalized images (scanning from slide or negative) in JPEG format. Files on CD or DVD must : high resolution **JPEG** sRGB colour profile, with 300 dpi resolution and 45 cm largest side, named with: first three letters of the name, first three letters of the last name, category number, progressive number (ex. *Marco Ferrari category1 photo1* becomes: **marfer11**)
- CD/DVD must bring on the side the full name, the address, the telephone number and a e-mail address.
- Each author can present a maximum of 5 (five) images for each category, for a total of 20 images.
- All photos must precisely reflect the object and the scene as it appeared to the photographer.

- e. Photos digitally altered beyond the standards of optimization will be disqualified. Allowed changes are: adjustments of color, contrast, brightness and neatness, the dust or marks removal and the cutting. Composed photos (combination of two or more photos), the addition, the duplication, the cancellation or the move of objects in the photo, or the use of digital artistic filters are not allowed.
- f. Images representing domestic, courtyard or in captivity animals are not allowed.
- g. Works that received prizes in other national or international contests are not allowed.

#### **Art. 5 Modalities of registration, requirements and condition for the participation and exclusions**

- a. The contest is open to all comers, amateur or professionals photographers of all age and nationality.
- b. The participation to the contest is subordinate to the registration that must be effected compiling the card of participation, enclosed to this regulation and available at the [www.podeltabirdfair.it](http://www.podeltabirdfair.it) web site.
- c. The delivery of the card of participation, together with the CD/DVD, can happen through postal delivery or by hand to the following address: **Photographic Contest Delta in Focus 2012 c/o Delta 2000 limited liability Consortium Company, Strada Luigia, 8 San Giovanni di Ostellato (FE)** within and not over 5.00 p.m. on March, 16<sup>th</sup> 2012.
- d. Works reached and not equipped by the dispatch in papery form of the card of compiled registration in every part will be automatically excluded by the contest.
- e. Works produced or referable to components of the organizational Staff or of the Jury are not allowed.

#### **Art. 6 Utilization of the photographic material**

- a. Sent photos won't be returned, winning works will become part of Delta 2000's photographic archive, in relation to the modalities used for the protection of the anonymity, we inform that such photos can be used for promotional and popular purposes without profit finalities, always citing the author's full name.
- b. Delta 2000 reserves the possibility to give information of the event, by press or television, reproducing the photos participating to the contest, citing the author.

#### **Art. 7 Responsibility of participants**

Each author is personally responsible for what constitutes object of presented works.

#### **Art. 8 The Jury**

The jury will be composed by n. 5 professionals photographers, experts of naturalistic photography, that will be selected on the basis of the specific competences and experiences matured in activity sector of reference and their judgment will be final.

#### **Art. 9 Prizes**

Each participant can be awarded only a prize.

Works can be transmitted from 30<sup>st</sup> January 2012 and they obligatorily must reach, in accordance with the modalities indicated in the art. 6, at Delta in Focus 2012 Contest c/o Delta 2000 limited liability Consortium Company, Strada Luigia, 8 San Giovanni di Ostellato (FE) by 16<sup>th</sup> April 2012.

#### **Art. 11 Awarding**

The ceremony of awarding will have place on 29<sup>th</sup> April 2012 at 3.30 p.m. at Sala Polivalente, Bellini's Palace, Via Agatopisto 7, Comacchio (FE) with projection of the best works.

Only the authors of the winning works will be contacted by telephone or e-mail.

#### **Art. 12 Final dispositions**

The participation to Delta in Focus 2012 Contest presupposes the general acceptance of the present regulation.

#### **Art. 13 L.D. informative 196/2003 on the Treatment of personal details.**

According to the art. 10 of the Law 675/96, "Protection of the people and other subjects in relating to the treatment of personal details" and following change with L.D. 30<sup>th</sup> June 2003 n. 196, the personal details supplied by Competitors with the compilation of the card of registration, collected and treated with computer tools, will be used to individualize the winners and to identify the authors of works in the different occasions when these will be projected or published and for communications related to the same contest.

The Competitor has the right to access to data that concern him and to practice the integration, rectification, cancellation rights etc. guaranteed by the art. 13 of the above mentioned Law, to the holder of the treatment.
